GENERAL INFORMATION 1.0

The Nigerian Institute of Town Planners (NITP) and Town Planners Registration Council of Nigeria (TOPREC) cordially invite you to the 2022 Edition of the Mandatory Continuing Professional Development Programme (MCPDP), which will be held at three centres (Uyo, Akure, and Ilorin) in the months of March, May and June, 2022, respectively. The programme is one of the capacity building initiatives of the Town Planners' professional arm, the NITP and its regulatory body, TOPREC, as stipulated in our constitution and laws.

The general aim of this Programme is to generate, disseminate and impart knowledge on relevant contemporary issues with a view to enriching the information base and improving the professional competence of Town Planners and related professionals in the built environment.
